

### E.1. INTRODUCTION

- The company under the name “NRG SUPPLY AND TRADING SINGLE-MEMBER ENERGY SOCIETE ANONYME” and distinctive title “NRG SUPPLY AND TRADING S.A.”, which has its seat at Amaroussion, at the junction of 168 Kifissia Avenue and Sofokleous street, with VAT No. 998102480 of the Athens FAE Tax Office, with GEMI No.: 008361601000 (hereinafter “Supplier”), is the holder of a Natural Gas Supply License pursuant to RAE Decision no. 356/2015 (2/10/2015), as amended and in force, and is registered as number 51 in the National Natural Gas Users Registry pursuant to RAE Decision no. 287/22-09- 2016 and lawfully exercises the activity of natural gas supply.
- The Supplier provides the floating commercial packages for natural gas supply (hereinafter “Packages”) to the Clients as referenced and analyzed in section E.2 of the present.
- The inclusion and participation of the Client in one of the Packages, as well as its terms and conditions, are determined by these special terms and conditions (hereinafter “Special Terms”). The Special Terms shall prevail over any contrary General Terms and Conditions. For matters not governed by these Special Terms, the Supplier’s General Terms and Conditions for the Supply of Natural Gas (the “General Terms”) shall apply.
- The Packages cannot be combined with other offers and/or discounts and/or promotional activities of the Supplier, if they relate to the same supply. The Packages participate in the “nrg Total” combined electricity/natural gas promotions, in which case any special terms and conditions of the above combined promotions, which are posted on the Supplier’s website [www.nrg.gr](http://www.nrg.gr), shall apply in addition.

### E.2. PACKAGES, DURATION & ADDRESSEES

According to the distinction below, the Packages are addressed to Residential and Non-Residential Clients who will choose to enroll in them during the period of their availability and have, on a case-by-case basis, the following duration.

### E.3. ENTRY INTO FORCE

The duration of the natural gas Packages shall commence:

- for new supplies of natural gas, on the date of the first representation of the new supply before the relevant operator; and
- for already represented gas supplies, on the date of conclusion of the relevant Gas Supply Contract (for Residential Clients and/or Low Pressure Professionals and Businesses).

### E.4. COMMISSION CHARGES

- For Client billing purposes, it is agreed that the Package's Supply Charges as set out in the Supplier's General Price Schedule of Offered Natural Gas Packages or the list of promotional activities under gas supply contracts\* and combined natural gas / electricity supply contract promotions & special terms thereof (\*Up to 1100Mwh/year per client) shall apply.
- The natural gas charge for the Package shall be determined on the basis of the Title Transfer Facility Price (hereinafter “TTF Price”) published

by the European Energy Exchange (hereinafter “EEX”) from time to time. The TTF Price shall be the price resulting from the virtual trading point for natural gas in the Netherlands, as more specifically set out in the Supplier’s General Price Schedule of Offered Natural Gas Packages. The TTF Price that nrg applies to its natural gas packages is equal to the TTF clearing price on the last day of the previous month from the month in which it is invoiced each time (reference month). The Price shall be published monthly on the EEX website: <https://www.powernext.com/futures-market-data>.

3. It is clarified that the TTF Price may be subject to significant fluctuations, depending on the prices of the natural gas futures (derivatives) traded by TTF participants. The evolution of the TTF Clearing Price for the period 1/2021 - 6/2022 and consequently the TTF Price applied by the Supplier for the billing of its clients' consumption in the month immediately following (from each clearance) is shown in detail in the following table:
